

**VILLAGE OF SUSSEX CORNER  
BY-LAW # 96 - 06**

**REMUNERATION OF COUNCIL**

The Council of the Village of Sussex Corner, under authority vested in it by Section 36 (3), Chapter M-22, of the *Municipalities Act* of the Province of New Brunswick, hereby enacts the following:

**1. TITLE**

This by-law may be cited as the “Remuneration of Council By-law”.

**2. INTERPRETATION**

In this by-law:

- (a) “*Council*” means the Council of the Village of Sussex Corner, and includes the Mayor, the Deputy Mayor and all of the Councillors;
- (b) “*Councillor*” means a Member of the Council other than the Mayor and Deputy Mayor;
- (c) “*Deputy Mayor*” means the Deputy Mayor of the Village of Sussex Corner;
- (d) “*Mayor*” means the Mayor of the Village of Sussex Corner;
- (e) “*Member*” means a person elected to the Council and includes the Mayor, the Deputy Mayor and all of the Councillors;
- (f) “*Related Meeting*” means a meeting of a related group or organization at which a Member attends as a representative of Council; and
- (g) “*Special Meeting of Council*” means a Meeting of Council (Open or Closed) in addition to the Regular Monthly Council Meetings.

**3. SALARIES**

Members shall each receive a salary as shown in Schedule “A” of this by-law.

**4. EXPENSE ALLOWANCES**

Members shall each receive a non-accountable general expense allowance as shown in Schedule “A” of this by-law.

Members shall each receive a non-accountable travel expense allowance as shown in Schedule “A” of this by-law.

**5. MEETING ALLOWANCES**

Members shall be paid for attending Special Meetings of Council as shown in Schedule “A” of this by-law. Members shall record attendance at these meetings on the Meeting Allowance Form shown as Schedule “B” of this by-law.

Members shall be paid for attending meetings of related groups or organizations as a representative of Council, with the exception of meetings for which other compensation is paid. Allowances for Related Meetings are shown in Schedule “A” of this by-law. Members shall record attendance at these meetings on the Meeting Allowance Form shown as Schedule “B” of this by-law.

**6. REVISIONS – SCHEDULE “A”**

Revisions to the content of Schedule “A” may be made by resolution of Council. Any such revision / resolution shall be made no later than December 14<sup>th</sup> of any one year with an effective date in the following year.

**7. ENACTMENT / REPEAL**

This by-law shall become effective on the enactment date shown below and, at that time, the following by-law and any amendments thereto shall be repealed:
